Purpose of processing	If a different person than the owner or the person authorized to receive the found object receives it, then Controller hands over the data to the investigation authority or to the competent court at their request.
Duration of processing	Controller deletes your personal data – considering that pursuant to Civil Code 5:59 (3), the Controller shall retain possession of the found object for a period of three months - 3 months after the official end of the Festival; in case of third party claim within 3 months from the official end of the Festival, immediately after the enforcement of the claims, but at the latest following the statutory limitation period.
Legal basis for processing	The legal basis for processing is the legitimate interest of a third party (the owner of the lost object) pursuant to GDPR Article 6 Paragraph 1 f), so in case a different person receives the lost object, the rightful owner can enforce his or her claim.

Personal data are processed by the employees of the Controller in order to achieve the	

abovementioned purpose.

## **Rights, legal remedies, complaints**

Pursuant to the GDPR, you may request access to the personal data and may request information about data processing (which will be provided by the Controller within no more than 30 days), may request rectification of personal data (except for your signature, due to its nature) or their erasure (to the extent this is reasonably possible). Such erasure does not affect the lawfulness of processing based on consent before its withdrawal. You may request the restriction of data processing and you have the right to data portability.
